

# URGENT!! YOU MUST CALL!

## ***Defend your Religious Freedom of Conscience in Oklahoma!!***

Barronelle Stutzman, a 72 year old Christian woman who owned Arlene's Flowers in Richmond, Washington, is being persecuted for her Biblical values. Barronelle did not discriminate against anyone.



She employed members of the LGBT community and sold floral arrangements to the LGBT community including the couple which sued her.

After the illegal Obergefel Supreme Court ruling in 2015, she declined to make floral bouquets for a same-sex wedding saying that such action by her would in effect sanction what she believed was contrary to clear Bible teaching about marriage and would violate her Religious Liberty. She then gave the couple numbers to florists that would provide the flowers. Although they suffered no damage, they are intent on ruining her financially and bullying anyone who dares disagree with their lifestyle.

This 72-year-old grandmother now faces over \$2 million in penalties leaving her destitute in her senior years.

**The House can simply substitute the language of SB197 (*which protects ALL Oklahomans*) to replace the language of SB1140 (*which only protects adoption agencies*). Let's make the change in the House and call on Senator Treat to keep his word and accept the changes in the Senate.**

## **Two Steps**

- 1) Call the House author Representative Travis Dunlap at (405) 557-7402 and say: ***"My name is \_\_\_\_\_ . I want to ask Representative Dunlap to insert the language of Senate Bill 197 into SB1140. All Oklahoman's should have their religious liberty protected."***
- 2) Then send an email to members of the House (see below) saying: ***"Senator Treat has given his support to SB197 (Silk/Dunlap). We ask that the language of SB1140 be amended and substituted with the language of SB197. The religious liberty of ALL Oklahomans must be protected."***
